- 5. That my client has raised an invoice on 16/09/23 for an amount of Rs. 6,290.28/-, which was the salary earned by the worker for working 12 number of days in August month of year 2023. The said invoice has been sent to you over email ID mi.gautam@yahoo.it
- 6. <u>That inspite of acknowledging the liability of payment of principal balance of Rs. 6,290.28/- you have failed to make payment of the said amount due to my client from you deliberately with malafide intent, hence you are liable to pay the said principal balance amount of Rs. 6,290.28/- along with interest @ 24% p.a. from the date of due till actual realization of the said sum as is generally and customarily prevailing in the trade usages.</u>
