Under instructions from and on behalf of my above-named client, I hereby serve upon you this legal notice, the contents whereof you may please note:

- 1. That my client is a private limited company under the name and style of M/s Broomees India Pvt. Ltd.
- 2. That my client is engaged in the business of connecting domestic workers to its clients.
- 3. That against your valid and confirmed booking, my client has provided you a domestic worker with the monthly salary of INR 18,000/- and under the terms and conditions mentioned on your invoice dated 13/02/24 & invoice reference number INV-BR-023915. The same T&C is also available on my client's website which you have accepted virtually while making the booking and checking the "I agree to the Terms & Conditions".
- 4. That as per the **point no. 7** in the T&C, you're liable to pay the worker's salary to my customer's account at the end of every month for the number of days he/she has worked during that month.
- 5. That my client has raised an invoice on time on 25/03/24 & 25/04/24 for the amounts Rs. 19782.14 & Rs. 3,600 which was the salary earned by the worker(s) for 40 number of working days in March & April months of year 2024. The said invoice has been sent to you over email ID eshaagarwal138@gmail.com
- 6. That inspite of acknowledging the liability of payment of principal balance of **Rs. 23,382.14/-** you have failed to make payment of the said amount due to my client from you deliberately with malafide intent, hence you are liable to pay the said principal balance amount of **Rs. 23,382.14/-** along with **interest** @ 24% p.a. from the date of due till actual realization of the said sum as is generally and customarily prevailing in the trade usages.
- 7. That my client requested you several times through telephonic message for release of the said outstanding payment, but you have deliberately ignored and delayed the same on one pretext or the other and so far have not paid the outstanding undisputed amount.

I, therefore, through this Notice finally call upon you to pay to my client **Rs. 23,382.14/-** along with future interest @ 24 % p.a. from the date of notice till actual realization of the said amount, together with **Notice Fee of Rs. 15,000/-** to my client either in cash or options mentioned in your invoice, within clear 3 days from the date of receipt of this notice, failing which my client has given me clear instructions to file civil as
